TERMS AND CONDITIONS

- 1) Vendors shall submit the required booth fee with application.
- 2) Load-in time: two days prior to event date.
- 3) Due to increased security measures, never leave your vehicle unattended at any time while within the venue. Do not leave backpacks, packages, boxes, bags, unattended outside your booth at any time.
- 4) Vendors are required to be open on Saturday and Sunday from opening to end of event. Closing before end of event or staying open after end of event is grounds for exclusion from participation at future events.
- 5) Consumption of alcoholic beverages by vendors at their booth is prohibited.
- 6) Vendors must provide trash receptacles for waste generated by their booth. Improper trash disposal is grounds for exclusion from participation at future events. Trash will be picked up after the event each night, if properly bagged and left in front of the booth.
- 7) Electrical requirements: All electrical appliances must conform to the uniform fire code of the specified county.
- 8) Permits: You are required to obtain and display all necessary permits and/or licenses in order to operate at the event. If you are forced to close by any government agency for failure to obtain your necessary permits and/or licenses, the Lucas Oil Off Road Racing Series is not liable and will not refund fees.
- 10) Refunds: Your booth and administration fees are NON-Refundable.
- 12) All vendors are required to notify Andrea Black if they are unable to attend the event after they have sent in the vendor application. Failure to do so within 72 hours of the Thursday before the event weekend will result in a penalty of the full price for the reserved space. This penalty must be paid before you will be admitted into the next event.

INSURANCE & INDEMNIFICATION

Vendors are required to carry a certificate of insurance from their insurance carrier indicating that their participation at the event is covered under that policy and **naming Lucas Oil Off Road Racing Series, I-10 Race Promotions, Inc. and Lucas Oil Products, Inc. as additionally insured.** The applicable date and event location to be listed on insurance certificate is **October 25-29, 2012 at Firebird International Raceway, 20,000 Maricopa Rd., Chandler, AZ 85226**

Comprehensive General Liability with the following minimum limits is required:

\$1,000,000 each occurrence / \$2,000,000 general aggregate.

\$1,000,000 Products and Completed Operations Liability each occurrence and aggregate.

\$1,000,000 Personal Advertising Injury each occurrence and aggregate.

The vendor for itself and its affiliates, personal representatives, heirs and next of kin agrees to indemnify and hold Lucas Oil Off Road Racing Series, I-10 Race Promotions, Inc., Lucas Oil Products, Inc., its directors, officers, employees, agents and representatives (the "Indemnities' ") harmless against, and in respect of, any and all claims, losses, expenses, costs, obligations and liabilities asserted or imposed upon any Indemnities' in connection with, or arising out of, any claim, action, suit, proceeding, or appeal (such expenses to include the cost of reasonable settlements made with a view of curtailment of the costs of litigation) which result from the negligent act or omission of Vendor or is in any way connected with their participation in the event. The vendor hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the event(s) whether caused by the negligence of the undersigned or otherwise.

Vendor shall not admit liability for or settle any claim, action, suit, proceeding, or appeal or incur any costs or expenses which are subject to this indemnification without the express written consent of Lucas Oil Off Road Racing Series, I-10 Race Promotions, Inc. and Lucas Oil Products, Inc., which shall be entitled at any time to take over and conduct in the Indemnity's name the defense of any claim, action, suit, proceeding or appeal.
