



2014 Contingency Requirements

- \$500 cash or \$1,000 product award per event weekend
- If only supporting Karts a minimum of \$100 cash or \$300 product per event weekend

Contingency awards

- Must be paid in full 1 week after finalized results are sent, unless the specified award is an end of the year championship award given to the top winner in the series in their class.
- Must be specified to which class will receive the award and to what place it rewards (i.e. only 1st place, top 3 racers, or top 3 racers running your specific parts, etc.)
- Awards must be given (to at least one class) at every event
- May create specific awards
- Must provide proof of payment to drivers. If any driver receives your award you must fax, email or mail evidence of payout to the specific driver to contingency director no later than one week after results have been sent.

Administration Fee

- All companies wishing to participate in Lucas Oil Off Road Racing Series Contingency program will be required to pay a \$250 administration fee to be accompanied by the contingency agreement one week or more prior to the first event of the season.

Contingency Sponsor entitlements

- 2 weekend admission tickets per event for company representatives
- 1 complimentary 10 x 15 space on vendor row or \$300 credit towards larger space if needed
- 1 participant parking pass
- 1 banner displayed in tech area (banner must be furnished by company)

- **Jr 2 Kart**- Custom built single seat mini race truck with Honda spec engine driven by children ranging from 8-15 years

TERMS AND CONDITIONS FOR ALL VENDORS

- 1) Vendors shall submit the required booth fee with application.
- 2) Load-in time: two days prior to first event date.
- 3) Vendors are required to be open on Saturday and Sunday from opening to end of event. Closing before end of event or staying open after end of event is grounds for exclusion from participation at future events.
- 4) Professional and appropriate attire is required. Company shirts are highly recommended.
- 5) Displays must look professional. No beat up, tattered EZ ups.
- 6) All companies may sell out their display with proper seller's permit. No alcoholic beverages or tobacco products may be sampled or sold.
- 7) Consumption of alcoholic beverages by vendors at their booth is prohibited.
- 8) All companies will receive 1 participant parking pass. Personal vehicles must be parked in participant parking. Load/unload passes will only be issued Thurs & Fri for the purpose of moving display/sale items in and out of the facility. Personal cars cannot be parked on vendor row during the event.
- 9) **AT ALL EVENTS DISPLAYS ARE NOT TO BE BROKEN DOWN UNTIL 30 MINUTES AFTER THE LAST EVENT ON SUNDAY. IF SET UP IS BROKEN DOWN BEFORE SPECIFIED TIME, WE RESERVE THE RIGHT TO CHARGE A \$250 FEE.**



- 10) Vendors must provide trash receptacles for waste generated by their booth. Improper trash disposal is grounds for exclusion from participation at future events. Trash will be picked up after the event each night, if properly bagged and left in front of the booth.
- 11) Electrical requirements: All electrical appliances must conform to the uniform fire code of the specified county.
- 12) Electrical needs (generator etc.) is the sole responsibility of vendor/booth.
- 13) All contracts must be received one week prior to event in order to reserve a space. If all necessary information is not received in time, you will not be permitted to participate in the event. NO EXCEPTIONS.
- 14) All vendors and contingency sponsors are required to notify the series if they are unable to attend an event when they have specified in their contract they would attend. Failure to do so within 72 hours of the vendors move in day (Thursday before the event weekend) will result in a penalty of the full price for the reserved space. This penalty must be paid before you will be admitted into the next event.
- 15) Permits: You are required to obtain and display all necessary permits and/or licenses in order to operate at the venue. If you are forced to close by any government agency for failure to obtain your necessary permits and/or licenses, Lucas Oil Off Road Racing Series is not liable and will not refund fees.
- 16) Insurance: You must provide proof of general liability insurance naming Lucas Oil Off Road Racing Series, I-10 Race Promotions, Inc. and Lucas Oil Products, Inc. and the applicable event location as additional insured.
- 17) Refunds: Your booth and administration fees are NON- Refundable.
- 18) In consideration of being permitted to or participate in any way in the event(s), the undersigned, for itself or its affiliates, personal representatives, heirs and next of kin: Hereby agrees to indemnify and save and hold harmless Lucas Oil Off Road Racing Series, I-10 Race Promotions, Inc., Lucas Oil Products, Inc., its successors, affiliates, officers, members, agents, and assigns from any loss, liability, damage, or costs they may incur arising out of or related to the event(s) caused by negligence of the undersigned or in any way connected with their participation in the event(s) The undersigned hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to event(s) whether caused by the negligence of the undersigned or otherwise.

- 20) In the event Vendor uses a display vehicle, the branding on the display vehicle must represent the brand of Vendor's business or the brand of a non-competitor to the partners and/or sponsors of the LOORRS. In the unlikely event a competitor brand is on a display vehicle, such branding must only be on the bedside/quarter panel of any display vehicle. LOORRS reserves the right, in its own discretion, to refuse any display vehicles with competitive brands.

2014 Event Dates and Insurance information
